

## Lewis's "good trouble" extends to LGBTQ voters, too

Civil rights icon U.S. Rep. John Lewis, who died on July 17th of pancreatic cancer, spent his life advocating equal access to the ballot for all Americans. Lewis nearly lost his life on Bloody Sunday, March 7, 1965, when he attempted to lead a nonviolent voting-rights march from Selma to Montgomery. He was beaten at the foot of the Edmund Pettus Bridge, resulting in a fractured skull. Fifty-five years later, on July 26, was Lewis's final crossing of the Edmund Pettus Bridge as a horse-drawn carriage carried his flag-draped casket.

John Lewis, the 'conscience of Congress, preached a lived theology and activism of "good trouble." Good trouble was the work of the 1960s Civil Rights Movement, and it was an expression of Lewis's faith. The

immediacy of his "good trouble" was heard in his jeremiads, inviting all to action to right wrongs. "If not us, then who? If not now, then when?" Lewis repeatedly said throughout his lifetime.

Lewis's clarion call for "good trouble" advocated for LGBTQ civil rights, too. The then living Black Civil Rights icons who gave

### Police: Man punches South End store clerk in the face in failed shoplifting attempt

#### Then returns with a switchblade

Boston Police report arresting a Dedham man they say really, really wanted to steal stuff from the 7-Eleven on Washington Street at Massachusetts Avenue in the South End on Sunday, July 26.

Police say that Daniel Moreno, 23, first entered the store around 5 p.m., lifted several items, then tried to leave - only to be confronted by store clerks who weren't having it.

In the ensuing altercation, the suspect punched one of the victims

in the face. However, the victims were able to retrieve the store property from the suspect before he fled the area.

But then Moreno returned, this time "significantly more agitated, and brandishing a switchblade," police say.

The victims stated the suspect lunged toward them with the knife in hand, grabbing various items from the rack before again fleeing the store, successfully stealing multiple items in the process.

Police say Moreno did not have much time to enjoy whatever it was he took: Armed with a detailed description, officers on patrol soon found him a couple blocks away at Mass. and Cass, where they arrested him on charges of armed robbery, assault by means of a dangerous weapon, assault and battery and larceny under \$1,200. Police add that Moreno was already wanted on

full-throated support for LGBTQ struggles as a legitimate civil rights were Coretta Scott King, Julian Bond, and John Lewis. Lewis's advocacy for LGBTQ rights was informed during his formative years in the Civil Rights Movement, understanding all human rights need protection. In advising LGBTQ activists to make "good trouble," Lewis stated the following:

"If we are going to continue to make progress, whether it is for marriage equality or discrimination against members of the gay community in the workplace, you have to continue to be physical, continue to speak up and speak out. To find a way to do what I call 'making some noise, getting in the way,' and educating people and sensitizing them."

Lewis spoke out for LGBTQ rights that went against his fellow clergymen. For example, Lewis advocated for marriage equality. He thought to employ the landmark U.S. Supreme Court ruling in the *Loving v. Virginia* decision affirming the freedom to marry as a "basic civil right" of every American extend to LGBTQ Americans. As a theologically trained, ordained Baptist minister, his stance incensed Black clergy, one of the largest groups in opposition, here and across the country. "The gay community is pimping the civil rights movement and the history. In the view of many, it's racist at worst, cynical at best," the Rev. Eugene Rivers, a local African-American Boston minister and then president of the all-male National Ten Point Leadership Foundation, told *The Boston Globe* in 2003.

As a counterpunch to Rivers's homophobic position, Lewis penned an October 23, 2003 op-ed in the *Boston Globe* the following week titled "At a crossroads on gay unions." His statement highlighted the connection between black and LGBTQ civil rights struggles:

"I've heard the reasons for opposing civil marriage for same-sex couples. Cut through the distractions, and they stink of the same

fear, hatred, and intolerance I have known in racism and in bigotry."

Lewis's clarion calls for "good trouble" forced us to look at where we are in our democracy-whether it was advocating for black civil rights or LGBTQ civil rights. In this presidential election season, "good trouble" would be making sure all Americans have access to the ballot.

To honor Lewis's life and legacy and work of "good trouble," Democratic lawmakers want to pass the 2019 Voting Rights Advancement Act (VRAA) he fought for, and name it the John R. Lewis Voting Rights Act of 2020. The VRAA would prohibit discrimination against people of color and other marginalized communities, like LGBTQ voters, by assigning election observers to states or municipalities with repeated problems- especially those with a history of discrimination. It would give the federal government the ability to take action against them if the discrimination continued.

These are needed safeguards in this upcoming election. Lewis championed the bill to reverse the deleterious damage done by the 2013 *Shelby County v. Holder* decision, which invalidated a key portion of the Voting Rights Act of 1965. Regrettably, the Republican-controlled Senate ignored Lewis' request.

The GOP tactics to dissuade people of color to the polls pose challenges for many transgender voters, too, who have transitioned but do not have a government-issued photo ID reflecting their gender. The Williams Institute at UCLA found that ahead of this November's election, over 378,000 "voter-eligible transgender people do not have IDs that reflect their correct name and/or gender."

John Lewis said, "Never, ever be afraid to make some noise and get in good trouble, necessary trouble." To honor him, "good trouble" this November election would be to vote out our present Republican thugocracy. As LGBTQ voters, we don't have to capitulate to the powers that be, because the power of the people is greater than the people in power.

**SOUTH END:** Thomas C. "Tom" Boyden, 80, of Grotton, formerly of Brattleboro, VT, Columbus Avenue, South End and Watertown, died Sunday, July 19, 2020 at Health Alliance - Leominster Hospital following a lengthy struggle with Alzheimer's Disease.



Tom was born in Boston, May 1, 1940, the son of George A. and Virginia (Brown) Boyden and was a 1958 graduate of Brattleboro High School. He served as a call firefighter to the Brattleboro Fire Department. For four years Mr. Boyden served his country in the United States Coast Guard District Personnel Office in Boston.

For much of his career, Tom worked in Employee Relations beginning at Jordan Marsh Company for fifteen years then continuing to Lechmere Inc. for twelve years and finally at BJ's Wholesale before retiring in 1995.

Over the years he remained very active in the communities where he resided. He was a former member of the Watertown JayCees, Past Chairman of the Boston Retail Group, Past President of the Watertown Multi-Service Center, Charter Member and Board Member of the Harbor to Bay Bike-a-thon. In 2005 Tom spearheaded a movement to successfully rehab the Childe Hassam Park on Columbus Avenue in his South End neighborhood of Boston.

A proud Harley Davidson Motorcycle owner, Tom rode over 100,000 miles throughout the continental United States and all the Canadian provinces.

He leaves his wife of 52 years, Annemarie (Powers) Boyden; two daughters, Kimberly (Boyden) Casto of Shirley, Deborah Jean Boyden of Oakland, CA; four grandchildren, Cole Casto, Anthony L. Casto, Riley Weber and Conner Weber.

He was the brother of the late Jane Kropp of Huntington Beach, CA.

# South End Mixed-Income Housing Community Will Undergo Major Renovation

Massachusetts Housing Finance Agency (MassHousing) has provided a total of \$30.3 million in affordable housing financing to the Fenway Community Development Corporation for the refinancing, major renovation, and preservation of affordability for mixed-income households at the 97-unit Newcastle Saranac in Boston's South End.

Fenway CDC – in partnership with the Schochet Companies – acquired Newcastle Saranac through Chapter 40T, after the MassHousing Section 13A mortgage expired in March 2018 and the former owner intended to sell the property, putting the property's 97 affordable units at risk of converting to market-rate rents.

"The deep affordability of these units for nearly a hundred households, contrasted with the rents of market-rate housing in the area, made their preservation especially critical for maintaining the vibrancy and diversity of the neighborhood," said MassHousing Executive Director Chrystal Kornegay. "Thanks to a strong collaborative effort by the Commonwealth, the City of Boston, the Community Economic Development As-

sistance Corporation, the Fenway CDC, the Schochet Companies and the residents of Newcastle Saranac, the community will see affordable homes preserved and substantially renovated. MassHousing is pleased to be a partner in this important transaction."

"In Boston, we are committed to creating safe, stable housing for all Boston residents. I am proud that, together with our partners, we have been able to preserve the affordability of 97 homes in Boston," said Mayor Martin J. Walsh. "We will continue to preserve and grow our affordable housing stock in Boston, and the acquisition and renovation of this building will ensure that residents living here will not be priced out of their homes."

"Closing on this project in the midst of COVID-19 did not make this already very complex transaction any easier, but the public partners for this project truly went above and beyond to make sure it could close in time to get construction safely started. At one point I think we had someone from nearly every Department at the City working on this project – during COVID – to make sure it crossed the finish line," said Leah Cambi, Executive Director of Fenway CDC. "I want to extend my sincerest gratitude and thanks to everyone at the City of Boston, CEDAC,

MassHousing, and DHCD who helped make the Newcastle-Saranac Apartments project feasible. We could not have preserved and rehabbed these units without working with our public partners."

"Now, with ever more economic uncertainty coming our way we are beyond thrilled that these 97 units are preserved as affordable housing forever," said Schochet CEO Richard Henken. "These are great, beautiful properties in an outstanding location, and we are excited for the families who call them home now and will in the future."

MassHousing is providing Fenway CDC with a \$17.6 million tax-exempt construction and permanent loan, a \$10.5 million tax credit equity bridge loan, and \$2.25 million in Section 13A preservation financing.

The transaction also involved \$15.5 million in equity from the allocation of federal Low Income Housing Tax Credits by the Massachusetts Department of Housing and Community Development (DHCD), \$9 million in Section 133 preservation financing from DHCD and \$1.55 million in DHCD National Housing Trust financing, \$3 million from the City of Boston's Department of Neighborhood Development (DND), \$2.1 million in Fenway CDC sponsor loans, and

### HOMELESS SERVICES AND HOSPITAL CAPACITY

On April 2nd, Mayor Walsh announced that construction begins at the Boston Convention and Exhibition Center to add 500 beds for treating homeless adults who have tested positive for COVID-19 and need care, but do not require full hospitalization.

The City has released a Request for Proposals to secure a partner organization to operate the facility. If necessary, the Convention Center beds will be opened up for hospitals to use for sub-acute COVID patients in the general population.

These 500 beds will bring Boston's total number of new beds for homeless individuals to over 1,000. This includes Boston Medical Center's Newton Pavilion facility, which the City and State are working to re-purpose as a medical facility for homeless residents affected by the coronavirus.

### SMALL BUSINESS SUPPORT

On April 2nd, Mayor Walsh announced two new resources that will help small businesses during the public health crisis.

The City of Boston has created a Small Business Relief Fund. Drawing on a combination of City, federal, and private industry contributions, it establishes \$2 million in grant funding—capable of providing a lifeline to hundreds of local businesses at risk of shutting down permanently due to the crisis. It will be administered as a streamlined version of the City's Small Business Financing program. Small businesses can begin applying on Monday, April 6.

The City of Boston has also created a Financial Relief Handbook and FAQ document for small businesses. It's a resource for navigating both public and private capital programs. It puts information and guidance about all the different programs together in one place.

an estimated \$585,571 in income during construction. The Community Economic Development Assistance Corporation (CEDAC) provided \$31.7 million in acquisition financing in a previous transaction. The City of Boston contributed \$9.1 million in BPDA linkage funds toward the acquisition.

The Section 13A financing from MassHousing and DHCD resolves the expired 13A rental subsidy at Newcastle Saranac and helps prevent the property from potentially converting to market-rate rents.

The Commonwealth's Section 13A program was created by the Massachusetts Legislature in the 1970s to provide low-interest mortgage financing to affordable housing communities. Today, 13A communities serve some of the lowest income and most vulnerable populations in Massachusetts, including many elderly residents. The mortgages on these 13A housing communities are nearing or have reached maturity.

In response, MassHousing and DHCD have committed a total of \$100 million in capital to help preserve affordable 13A units that otherwise would convert to market rates.

Planned improvements at Newcastle Saranac include

significant site work, building envelope upgrades and extensive apartment upgrades. The brick, walkup buildings, Newcastle Court and the Saranac Building, which were built in the early 1900s at 599 and 627 Columbus Ave., have not been renovated since the 1970s.

There are 8 studio apartments, 29 one-bedroom apartments, 54 two-bedroom apartments, and 6 three-bedroom apartments at the property. Of the 97 units, 38 will be supported by project based housing vouchers and restricted to households earning at or below 30 percent of the Area Median Income (AMI), 31 apartments will be restricted to households earning at or below 60 percent of AMI, 13 apartments will be restricted to households earning at or below 80 percent of AMI and 15 units will be restricted to households earning at or below 100 percent of AMI. The AMI for Boston is \$119,000 for a household of four.

The general contractor is Keith Construction and the architect is The Architectural Team. Schochet Companies affiliate, Federal Management Co., Inc. is the property manager.

MassHousing has financed 12 rental developments in the South End involving 1,868 units and \$501.6 million in financing. The Agency has provided 8,497 home mortgage loans to Boston homebuyers and homeowners totaling \$1.1 billion in financing.

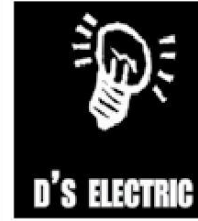
