Police Officer John Sacco, widely known for his usual tart conclusion that “the scoundrel was arrested on the spot.” Then we had food writer Lydia Walshin’s delectable series, called The South End Cooks, and

### Officers Recover Illegal Firearm, Arrest Two

At about 5:55 PM on Wednesday, May 18, 2016, members of the Youth Violence Strike Force effected an arrest for firearm related charges in the area of San Juan and West Brookline Streets.

as through the generosity of local neighborhood associations, cultural institutions and business groups.

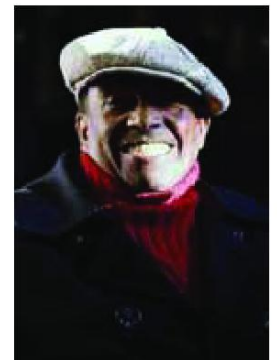

Dear Dog Lady,  
 As a dog lover and city resident, I'm curious to know your feelings about dog owners who claim they do good for the community while they don't seem to abide by local laws, or care about others in their neighborhoods as they completely ignore park laws and let their dogs run off-leash.

I go to two parks in my city neighborhood. There is signage about keeping your dog on leash but no one seems to care. I've talked about it with some of these dog owners, and they know they're breaking the law. They just don't seem to care. Of course they'll be the first at a community meeting to stand up and say: "We're a community!" Or, "We do a lot for the community!" Sure, as long as you're part of their community. Why don't the dog owners use the parks specifically designated as "dog parks" instead of using the green space everyone is supposed to share?

 Watching a cat or dog deep dream is one of the pleasures in life. Four paws twitch and flex. Whole furry body shakes. And the noise: "Yip, yip, yip. Grrrrr. Purrmmmm." You can only wonder about what it all means? Is your dog chasing a squirrel up a tree? Or is your cat conversing with a dog? Is they dreaming of things they know or of creature features we can't imagine?

Researchers at the Massachusetts Institute of Technology released a study showing laboratory rats dreamed about things in their experience (endless cage tumbling?). The neuroscientists reached their thesis because rats' brain waves while sleeping showed similar patterns to wakefulness.

Still, we cannot understand if pets' imaginings are variously scary, sultry or soothing. And what, if any, roles do two-legged people play in these dreams? She is walked and has the opportunity to "go" before being put in the car. We love to take her with us but the crying is becoming unbearable. How can we help her?

 The issues of dogs off the leash are a universal vexation for many; in this regard, you are definitely not alone. From here, you only get so much sympathy. Dog Lady admits she has enjoyed some of her happiest times when her dog is unleashed.

Ask Dog Lady is a column to encourage responsible dog guardianship and behavior so that we all can co-exist peaceably. Irresponsible owners ruin it for everybody when their unleashed dogs jump on or chase people. Reckless owners stink it up for everybody when they leave their dog's waste on the ground. Dog Lady believes these mutt miscreants should be zapped with very steep — \$500 to \$1000 — fines. But ban all dogs completely from city parks? Not quite.

Dear Car Crazy,  
 It's tough to fathom what noise emanates when a toy poodle "cries." Does your mini-poo wail and sob? Sniffle and whimper? If her reaction is so unbearable, don't take your dog in the car. Or give her something to keep her occupied while the car is moving — a favorite chewie, for instance. (Note: a bully stick is a great distraction for dogs). Maybe the misery is caused by the car carrier contraption. Since she's a tiny dog, a small crate will efficiently hold her in transit.

Your frustration is understandable but you don't explain why you are so enraged. Have you stepped in it? Has a dog bitten you? If so you should immediately contact the city's Animal Control office to report the criminal behavior. If you're ticked off because of dog owners' duplicity in declaring themselves

The South End News began to publish Ask Dog Lady in 2002 as a humor/lifestyle column about dogs, life and love when Collins was a media columnist and TV critic for USA Today, TV Guide and the Boston Herald. FOSEL has been lobbying BPL and City officials for a South End library five-phase renovation plan, that would, if approved, reconfigure the downstairs adult area in the next fiscal year, with subsequent and more dramatic changes the years after. FOSEL has offered to raise \$25,000 of the estimated \$100,000 first-phase cost, so you'll hear from us, soon. So far, the response has been positive but there will be no final decision until the end of June. In the meantime, the planned renovation study of Library Park may begin as soon as next fall. The 2016 South End Garden Tour will include Library Park on its schedule.

There will be four Summer Jazz Concerts with the fabulous Pat Loomis and His Friends, one scheduled in July and three in August. Details to come.

the larger group, one making several hand movements to his waistband as if checking the security of a firearm. Officers exited their cruiser and walked over to speak with the two males. Due to their observations and their knowledge of the area and the subjects, officers performed a pat frisk for their safety. The officer felt what he knew to be a firearm in the waistband of one of the males and recovered an unloaded revolver without markings indicating its make or model.

Officers placed the 16-year-old juvenile from Hyde Park under arrest for Unlawful Possession of a Firearm, as well as an outstanding warrant out of Suffolk County Juvenile Court.

As the officers made the arrest, the second male became belligerent, yelling at the officers and making a scene causing a large crowd of onlookers to gather in the street. After being warned several times to cease this behavior, 25-year-old Mwase H. Potts of Boston was placed under arrest and charged with Disorderly Conduct.

## BPD Cops Don't Shoot "Suicide By Cop" Suspect

At approximately 2:15 pm on Friday, May 20, 2016, an officer sitting inside of his department motor vehicle in the rear parking lot at District D-4 (South End) was approached by an individual who stated to the officer, "Can you do me a favor?" The officer responded

that he could and then asked the individual what he could do for him. To which, the individual replied, "I want you to shoot me, kill me, I want to die."

At this time, the officer immediately radioed for assistance. While the suspect continued to repeat his demands for the officer to harm him, the officer quickly exited his cruiser and promptly noticed that the suspect had his hands concealed behind his back. Despite repeated commands to show his hands, the suspect refused. As other officers arrived on scene, the suspect charged at the officer, punching and attempting to tackle him. The suspect then grabbed for the officer's department-issued firearm and repeatedly tried to pull the weapon from its holster. Fortunately, the officer was able to pull away from the suspect and successfully fend off his attempt to take his weapon. While being placed into custody, the suspect continued to verbally disrespect and disparage the officers.

The suspect, Arthur Campbell, 35, of Boston was arrested and officers requested that EMS respond, at which point the suspect was transported to Boston Medical Center for an evaluation. The suspect will be charged with Assault and Battery on a Police Officer.

Boston Police Commissioner Evans stated, "An incident like this underscores the dangers my officers face every day. I can't praise their handling of this situation enough. Their response to an officer in trouble call was quick and decisive and the restraint shown to a suspect intent and hell-bent on harming

**Officers Make Quick Arrest After Bank Robbery**

At about 11:38 AM on Saturday May 21, 2016, officers assigned to District D-4 (South End) made an arrest after a bank robbery at 1320 Washington Street. Officers responded to the Commerce Bank where a male suspect, later identified as Jeremy Woodley, 35, of

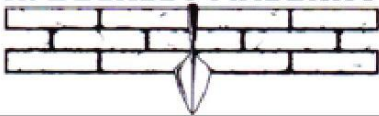

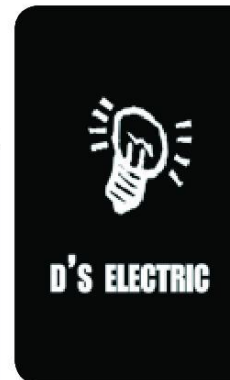
