Upcoming caucuses help shape Dems' future

Since the inauguration of the new president barely two months ago, the heads of many residents Massachusetts, of the city of Boston and of the South End have been spinning in disbelief. Many are angry and shocked at executive orders, legislative proposals, nomi-

nees and plans for the future that they see as hostile to civil rights, immigrants, the environment, and the financially vulnerable, but feel that with a Republican majority in Congress, there is a trajectory that will be difficult to stop.

Blue voters will have an oppor-

tunity to plan the future of their party in the upcoming Democratic Party caucuses taking place in the neighborhood and throughout the state from now through April 2. ing on our party platform in Worcester, and we want to make sure that every Democrat has a voice in this process. This is a time for all of us to come together and speak to our shared Democratic values."

The Ward 8 Democratic Committee will hold its caucus on Saturday, March 25 at 11:00 AM at the Boston Police Department District B-2 station, 2400 Washington Street.

Any registered Democratic voter can register to run for one of the 15 delegate and 4 alternate spots. Ward 8 Democratic Committee chairperson Joy DePina said via e-mail that elected officials usually attend the annual caucus to meet attendees. Asked to explain how involvement in the caucus commented, "Municipal engagement is the closest you can get to affecting every day challenges."

Following Ward 8 is the Ward 4 Democratic Committee caucus to be held promptly at 6:00 PM on Wednesday, March 29 at the

South End Branch Library, 685 Tremont Street. Brownsberger (D-2nd Suffolk and Middlesex) plan to appear at the caucus as well.

Once the voting is over, attendees will have a chance to meet and greet hopefuls for the City Council District 2 and District 7 races, both of which represent the South End. Deejo Jibril, candidate for Tito Jackson’s District 7 City Council seat and Corey Dinopoulos, who is running to succeed Bill Linehan as city councilor for District 2, also plan to attend. Olmstead added that the Ward 4 Democratic Committee meets every third Tuesday at 6:00 at the South End Library and all Ward 4 residents are welcome to attend.

Ward 9 Democratic Committee Secretary/Clerk Richard Shibley reported that the Ward 9 Democrats will hold their caucus on Saturday, April 1 at 11:00 AM at the South End Community Health Center, 1601 Washington Street, in the WIC conference room

on the second floor. Registration for the 9 male and 9 female delegate slots plus four alternates closes at 11:15 AM, at which time the caucus convenes.

Shibley, who served as Deputy Secretary of State from 1987-1995, explained that the state conventions in odd numbered years such as 2017 are issue-oriented, and there is less competition for delegate seats in those years. “I hope that people will be motivated,” he said. Shibley feels that the caucus offers voters a chance at increased empowerment. “The thing that’s nice about a neighborhood caucus is that it’s accessible,” he observed in a telephone interview. “Sometimes people feel like they can’t make a difference. At your ward caucus, you can make a difference. If you don’t like what’s going on in Washington, the most effective thing to do is organize. It might not have immediate effect, but you will have a lasting effect!”

Soup for the soul

Grand Concourse, SpeakEasy Stage Company, Roberts Theatre, Calderwood Pavilion, Boston Center for the Arts, through April 1. 617-933-8600 or bostontheatrescene.com

The Bronx ecumenical soup kitchen in the 2014 drama "Grand Concourse" looks like something from today's headlines. Christian and Jewish New Yorkers come together with the guidance of a very caring kitchen-running nun named Shelley. Playwright Heidi Schreck, who worked in soup kitchens herself while growing up, sees the title not only as the pivotal Bronx street but also as the term for a grand meeting. The disarmingly mundane 'grand meeting' in her engaging Off-Broadway effort calls into question such big issues as faith, individual commitment and forgiveness for four very different characters- a meeting vividly evoked in the play's New England premiere (through April 1 at the Calderwood Pavilion) by SpeakEasy Stage Company.

"Grand Concourse" finds Shelley, maintenance man and security guard Oscar, homeless Jewish veteran Frog and young (19) volunteer Emma returning daily to the soup kitchen in question much as the movie theater workers and a patron come

together in the similarly structured 2013 Annie Baker play "The Flick" (Schreck not surprisingly familiar with Baker's work as an actress in one of her plays). All four deal with unresolved issues and seek real validation as human beings. Sister Shelley, having a crisis of faith, struggles to complete a personal prayer to God "for all people," one that calls for "justice for immigrants." Oscar, who once studied dentistry for a year in his native Dominican Republic, now studies towards a degree at a community college but wonders whether he and (unseen) girlfriend Rosa can make a life together. Frog, good-natured but paranoid and volatile when off medication, sells joke books and craves attention- especially networking to find a job.

Serving as a catalyst for resolving their respective issues as well as her own is kitchen newcomer Emma. Kicked out of college and seeking direction, the seemingly aimless young volunteer tells Shelley she wishes her mother would treat her like a normal person and eventually looks to the empathetic nun for emotional support and understanding. Flirting with Oscar and crossing the proverbial line (in a scene that makes the play appropriate for adults), she leads him to question his feelings for her and for Rosa. At the same time, her positive interaction with Frog involves finding him interviews for work and job possibilities- one which turns into a real receptionist position

and more self-respect. Her own formidable challenges appear to be a mother-daughter conflict, leukemia and chemotherapy.

Ultimately, a stunning revelation forces Shelley, Oscar and Frog to re-examine their respective relationships with Emma. Has she been honest with each of them? Has she been honest with herself? Is she worthy of sympathy and forgiveness? Schreck makes their individual confrontations with her dramatically satisfying. That is particularly the case with Shelley's last scene actions which the playwright intriguingly labels "a kind of benediction."

For her part, pains-taking director Bridget Kathleen O'Leary is blessed with a cast that strongly evokes the characters' respective ups and downs and evolving fortunes. Melinda Lopez captures Shelley's world-weariness and self-doubts regarding her beliefs. Her last scene evocation of the conflicted nun's growing elation and joy as she makes a life-changing decision is the kind of seamless acting that all theater students should carefully examine. Alejandro Simoes has all of Oscar's charisma, great energy and


emotional impulsiveness. Thomas Derrah catches Frog's likeability and elusiveness as well as his vulnerability- the last most notably when a missed medication leads to a visceral outburst. Ally Dawson does well with the tricky role of alternately diligent and derelict Emma. Her properly complex characterization means that individual audience members may ultimately find themselves debating Emma's real intentions.

Jenna McFarland Lord's soup kitchen design has remarkable authenticity- complete with a full complement of industrial kitchen appliances, utensils and pots. Her vivid set also includes stained glass arcs above to evoke the church. Karen Perlow's expressive lighting finds the alternate brightness and shadow of the kitchen quartet's fortunes.

"Grand Concourse" may not provide breakthrough insight about its characters' priorities and beliefs or reach the visual epiphany and cumulative insight of Baker's "The Flick." Still, SpeakEasy Stage takes theatergoers on an exhilarating ride in Schreck's heartfelt play.

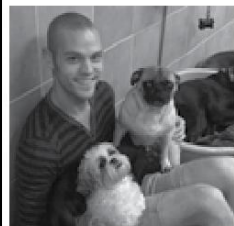

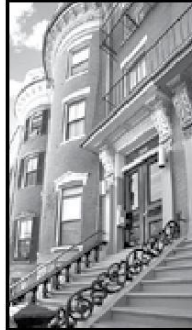
