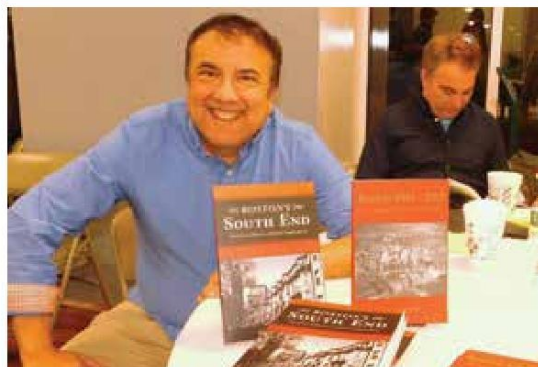

What constitutes real family? Buffalo native Simone seems to think that earning more than \$100,000 a year, living in what she describes as her own carriage house and enjoying 500 feet of private beach at her employer's fancy summer home on Martha's Vineyard prove that she belongs.

Do the Architectural Digest-like estate's high maintenance trophy wife Michaela Kell and her successful unseen husband Peter agree? Where does Simone's unassuming but insightful visiting sister Devon fit in at this apparent paradise on earth?

United South End Settlements (USES) is recruiting two runners who are passionate about our mission to run the 2018 Boston Marathon and fundraise in support of our mission. We encourage our South End neighbors to apply.

USES has been an official non-profit partner with John Hancock providing bibs to runners for the past two years, with runners on Team USES raising \$15,513 the first year and \$37,742 last year. The fundraising minimum requirement for Team USES in 2018 is \$10,000 per runner.

USES will support runners with their training and fundraising, including coaching through Heartbreak Hill Running Company,

online fundraising support, email communication design, fundraising and post-marathon celebration space, connections to local restaurants and business for fundraising support, tickets to The Neighborhood Gala in May 2018, and a tour and orientation to help runners become familiar with USES's programs and participants.

Through their fundraising work, runners will support USES's mission to harness the power of our diverse community to disrupt the cycle of poverty for children and their families. There is great need in our community: 36% of children in the South End live below the poverty line and we know that a child raised in a household in the poorest fifth of the income distribution has a 39% chance of being stuck at the bottom as an adult and just a 7% chance of making it to the top.

Nonetheless, there is also great opportunity: a \$3,000 difference in parents' income when their child is young is associated with

a 17% increase in the child's future earnings. At USES, we believe that families have the best chance to reach their potential when we support the whole family together – children, parents, caregivers, and other family members: we work with parents and caregivers to develop their own capacity to reach their goals through coaching, increase their income and assets through job training and placement, and expand their social networks through community connections.

For children, we provide quality education & enrichment opportunities through early childhood education, after school, and a summer sleepaway camp that promote their own development, expand their horizons, and ready them for school and beyond.

becomes clear and telling as Simone and Devon differ about which sister failed to identify the title letters as distinct parts of the alphabet, only to be cruelly called a 'retard' at school.

This difference actually becomes a kind of microcosm for the considerable distinctions between them and how they look at life and people. Simone thinks her newfound boyfriend Ethan, an associate of Peter's, is 'the real deal,' but Devon perceptively sees him as a flighty airhead. Simone believes that she and Michaela are best friends forever, but Devon sees through her exaggerated sense of security.

Later Michaela's emotional volatility takes its toll not only on herself but also on Simone. Michaela's trophy wife status, it turns out, is very much in jeopardy as Peter has pushed her out of his Jaguar, making her feel "like a homeless woman." As a scorned wife, she is even ready to turn on Simone during her escalating rage.

Despite Devon's sharp appraisal of Simone's precarious situation, Metzler is savvy enough as a young writer not to give the impression that she is all knowing and angelic. As part of the play's generally balanced dialogue, she has Simone remind Devon that she had helped her move to San Francisco at one point but the latter has not been keeping in touch.

Devon's mixed back story includes a disturbing and ultimately damaging online relationship with a boyfriend named

Tim who is revealed to be a "raging sex addict." Even so, sibling solidarity ultimately overcomes a variety of challenges.

Director Shana Cozansky keeps all of these challenges and the sisters' rollercoaster ride of reactions and responses fast-paced and fully convincing. Lydia Barnett-Mulligan captures Simone's naiveté and vulnerability without turning her into a caricature. Amanda Collins finds all of Devon's initial reserve as well as her protective stance for Simone.

Samantha Richert gives full expression to Michaela's bitchiness and fury but does equally well with her disillusion about Peter and her life. Metzler has been working on the part of Michaela and now calls her 2011 work "a new play."

Michaela's moment of truth may need to begin a bit earlier, but Richert makes her transformation stunningly haunting. Barlow Adamson has the right cheery elusiveness as Ethan. The other standout besides Richert is Jaime Carrillo as Jos-B, a put-upon Puerto Rican caretaker who is wrongly identified as Cuban by Michaela. Carrillo's timing is rapier-sharp as he dispels prejudicial assumptions.

Jeffrey Peterson's summer home set—complete with stage left beach terrain—is one of the best designs to grace the BPT in decades. A stage right door becomes a kind of silent transparent character as audience members witness Michaela raging with Simone behind its glass.

Beyond edgy humor and witty banter, "Elemeno Pea" makes human caring and sibling power as basic as ABC. BPT's staging is letter perfect.

Historic Neighborhood" and the recently released "Boston 1945-2015: The Decline and Rebirth of a Great World City"; and librarian Anne Smart of the South End Branch Library. In a departure from the previous two years, the festival moved from the Harriet Tubman House at United South End Settlements to the Harry Dow Room, named for Harry Dow, a local immigration lawyer and community activist who was the first Chinese American to be admitted to the bar in Massachusetts.

Lopez was happy with attendance. "It was a pretty good turnout. I'm not sure how many more people we could have had without violating the fire code!" he quipped. Many of the authors sold at least a portion of their inventory, and Lopez observed, "An event like this will often boost on-line sales for at least a couple of days."

Legendary community activist, former mayoral candidate and founder of the South End Technology Center Mel King signed copies of his recently revised book, "Chain of Change" and talked with neighbors. King and his wife, Joyce, are lifelong South Enders.

Charlie Caizzi, who spent much of his life in the South End before moving to Middleboro some years ago, was a friendly presence right at the entrance to the book festival, introducing himself and his memoir of his youth in the neighborhood, "Just So You Know".

The title of Caizzi's book reflects the matter-of-fact storytelling of the book, which is peppered with funny and colorful slices of life. Author William Kuhn, who lives in the Ellis neighborhood, explores social history in his novels, "Prince Harry, Boy to Man" and "Mrs. Queen Takes the Train" and his non-fiction work, "Reading Jackie: Her Autobiography in Books" about former First Lady Jacqueline Kennedy Onassis.

A full-time writer, Kuhn is now working on a book about

Lord Byron. While author Stephanie Schorow is not a South End resident, her books, "Combat Zone", "Drinking Boston" and "Boston on Fire" include episodes involving the South End as well as other nearby areas. Explaining the moniker of the former red-light district, Schorow said that the earliest reference to the "Combat Zone" came in a newspaper account of a judge who was sentencing a man who was charged with a barroom stabbing in 1950.

"The judge said, 'This [area] is terrible. Clean it up; it really is a combat zone,'" Schorow said. Schorow added that the name became more popular after an article in the Boston Record-American about shady activities in the Combat Zone.

Retired teacher Jean Cibran of West Canton Street presented her recent publication, "Kahlil Gibran: Beyond Borders", a revision of "Kahlil Gibran: His Life and World", an examination of the life of the poet Kahlil Gibran, author of "The Prophet".

Jean Cibran wrote the book with her late husband, the internationally renowned sculptor Kahlil C. Cibran, younger cousin of the poet. Jean Cibran also authored "Love Made Visible: Scenes from a Mostly Happy Marriage", a candid and eloquent memoir of her 50 years with the sculptor.

At the other end of the bright and airy venue, artist, illustrator and humorist Thom Donovan exhibited some of his work, which encompasses illustrations of the Emerald Necklace and a South End visitor map as well as a graphic novel on John Lennon's final days entitled "Lennon at Sea" and a book of clever, edgy verbal and visual puns entitled "Yes, Pun Intended".

Donovan feels the event is good exposure for his work. "I like it because it is my target demographic: baby boomers. Everyone knows who John Lennon is." One visitor to Donovan's table purchased 25 postcards of cartoons from "Yes, Pun Intended" and asked him to inscribe them on the back "To a Hero", with the intention to send them to soldiers over the holidays.

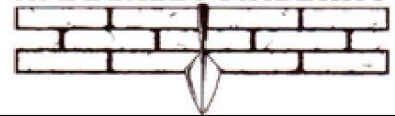
