### Friends of South End Library

The renovation process of Library Park on Tremont Street began with a public hearing last week at the South End Library. A new layout of the park was proposed and received numerous comments and suggestions. Details have not been firmed up but the broken bluestone center will be replaced with a meandering

path of shaded concrete; the patio between the library and the park will be expanded and opened up by eliminating the existing gates and columns; rain gardens are planned with curved seating; and numerous long-overdue infrastructure improvements will be made. The budget is limited (\$115,000) so private fundraising will likely ensue.

We, the Friends of the South

End Library (FOSEL), are ready: Are you? A hearing before South End Landmark District Commission (SELDC) is currently scheduled for January 2, 2018. Construction work should start in March and be completed by late summer. Details will be made available on our website, [www.friendsofsouthendlibrary.org](http://www.friendsofsouthendlibrary.org).

Walsh: 48-hour space-saver rule will remain in effect this winter - except in the South End

Mayor Walsh said last week it's steady as it goes for the city's informal rule that lets residents save parking spaces they've shoveled out after the end of a snowstorm serious enough to require declaration of an emergency declaration.

The one exception is the South

End, where the city will continue to ban all space saving all the time, Walsh said at his annual pre-winter preparation news conference at the DPW facility off I-93 in the South End.

Jerome Smith, the city's chief of civic engagement, asked residents to shovel out hydrants after a storm

The festive event, part of the citywide Enchanted Trolley Tour sponsored by the Mayor's Office of Tourism, Sports and Entertainment, was organized locally by the Ellis South End

Neighborhood Association and the BCA.

According to Emilio Gonzalez, director of community relations for the BCA, several hundred people attended the event, which offered a wide range of activities to amuse guests while they waited for the special guests, who were significantly delayed from their anticipated 4:30 arrival time.

Entertainment included music by the Community Music Center of Boston's Youth Chorus and High School Trumpeters; two

a cappella groups from Boston College, all-female the Sharps and all-male group the Heightsmen as well as an ornament-making led by local artist Eleanor Mary Cepko.

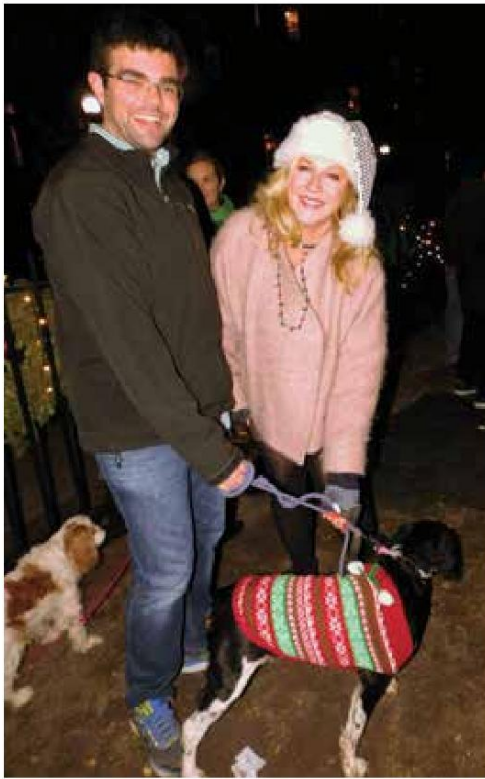

### Parking In Snowy Weather

It's important for us to keep main roads clear for plows and emergency vehicles during extreme weather. You will be ticketed and towed if you park on a posted snow emergency artery during a declared snow emergency.

#### Plows And Emergency Vehicles

Help us keep streets open to plows and emergency vehicles by parking at least 20 feet away from intersections and no further than 1 foot from the curb. Don't block sidewalks, fire hydrants, ramps, driveways, or the street with your vehicle.

#### Clear Your Muffler

For your safety, make sure to clear all snow at least one foot around your muffler before starting your engine. Blocked mufflers can cause carbon monoxide poisoning.

#### Towed Cars

If you believe your vehicle was towed in Boston, search the towing database or call the Boston Police Tow Line at 617-343-4629.

#### Space Savers

Did you use a trash can, cone, or some other object to save your parking space on the street? Here's what you need to know:

- You can only use a space saver when the City declares a snow emergency.
- You have 48 hours to use a space saver after we end an emergency. After that, you must remove it from the street.

#### Plow My Street, Please!

We prioritize clearing main routes — like Commonwealth, Hyde Park, and Blue Hill Avenues — so emergency vehicles can get to schools, hospitals, and homes quickly. If you think your street was missed by a plow, let us know by submitting a request to 311.

#### Shoveling

##### Property Owners Must:

- clear sidewalks within three hours of snowfall ending or three hours after sunrise if it snows overnight, and
- clear at least a 42-inch-wide path for wheelchairs and strollers.

Simply put, we're looking for an accessible path of travel. While the rule is three hours, we try to be reasonable for deciding when we start the clock. Our goal isn't to fine you. We just want people — especially youth and seniors — to be able to get around safely.

#### Shoveling Fines:

We have information on what you can expect to pay in fines each day your sidewalk is unshoveled, or if you shovel snow onto the street. We fine ourselves for City-owned properties too.

#### Things We Could Use Your Help With:

- Don't shovel or push snow into the street. If you do,

the City may fine you.

- Remove ice to bare pavement or make as level as possible and treat with sand, sawdust, or similar material. Every year dozens of people are seriously injured slipping and falling on sidewalks.
- Please clear any snow that may be blocking a handicap ramp, fire hydrant, or storm drain. If a hydrant is buried in snow, it takes the fire department time to find it and shovel it out.
- Don't leave snow or ice on stairways or fire escapes. All common means of exit must be clear in case of a fire or another emergency.

### Prepare For The Cold

#### Stay Safe During Extreme Cold

When you know severely cold weather is coming, remember to take steps to prepare. Please also check on your elderly or disabled neighbors, and take caution when using portable heating devices like space heaters.

#### Frostbite And Hypothermia

- Make sure to cover exposed skin and watch out for frostbite. In extreme cold, frostbite can happen in under a minute. Wind also increases the risk of frostbite.
- Hypothermia occurs when your body loses heat faster than it can retain heat. This can create a dangerously low body temperature.

#### Carbon Monoxide

- Every year, thousands of people are killed or seriously injured from breathing in carbon monoxide.
- Winter is a dangerous time for carbon monoxide poisoning. Make sure the exhaust pipe on your car is clear of snow, as well as your house's heater vent.

as they become available.

The South End library fundraising campaign, WRITING THE NEXT CHAPTER, has now embarked on the second and final phase of its proposed interior renovation plan to raise \$200,000. The first phase, to raise \$50,000 to add to a BPL allocation of \$132,000, was concluded within a short amount of time when the FOSSEL board contributed \$30,000 (with a 100 percent participation rate) and you, generous neighbors, friends and Eversource Energy, donated the \$20,000 in amounts ranging from \$25 to \$2,500.

Donations over the \$50,000 have been applied to the second phase. It will buy us 21st-century electric and digital systems, a teen space, new carpeting and paint, and a reconfigured seating area that is open and bright and has clear sight lines for library staff. The second phase will pay for a relocation of the circulation desk to open up additional spaces for,

among other things, a South End display for local history and authors, a small conference room, a new Children's Room and renovated staff quarters. The proposed design is on our banner on top.

Please donate as generously as you can by clicking on SUPPORT US to the best institution in our neighborhood, our local public library branch of the Boston Public Library. The funds we ask you to contribute will be augmented by another appropriation of capital funding that will be requested for the FY 2019 budget, for which we, the Friends of the South End Library, will be lobbying our local elected representatives in the very near future. We believe they are on our side. Some of our representatives have contributed to this campaign personally. We need you to step up, if you haven't already. For all of you who have, thank you, from the bottom of our hearts. Details about construction dates will be made available soon as we find out.

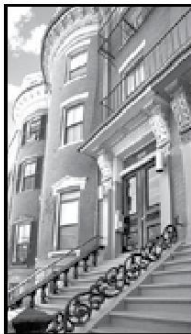

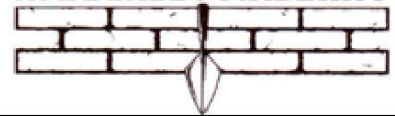
