household with a very spoiled eight-year-old female Brittany spaniel that has been the only dog in the house. The new puppy will also be a Brittany and we are thinking of getting a male. Any help with making the older dog comfortable during the transition is appreciated.

Dear Mo,  
Make sure none of the older dog's routines are disrupted during the time your household adjusts to the puppy. Walk the elder at the same time, feed her as you have been doing, and leave her crate or bed in the same place. Don't force her to pal around with the

puppy but let the two of them work out their relationship. Allow them hang out together casually but supervise them. Divide your attentions equally between the older dog and the puppy.

## Boston Sued By Mother Of Man Police Killed

BOSTON, MA — The mother of a black man fatally shot by Boston police filed a federal lawsuit Wednesday accusing the city of failing to

properly train officers on how to deal with people with mental illnesses.

Terrence Coleman, who was diagnosed with schizophrenia, was killed in 2016 after his mother called for an ambulance to take him to

the hospital. Police and prosecutors say he attacked emergency medical technicians with a large knife, but his mother denies her son was armed or

Airbnb tries to slime Boston city councilor instead of discussing its role in destroying entire neighborhoods

Airbnb is making it clear this week that not only does it oppose efforts by city councilors to regulate

the apartments and condos it advertises, it will take the low road to do it.

In e-mail to its "friends," the company writes:

Boston City Councilor Michelle Wu has a proposal that would place unreasonable restrictions on home sharing in the city and we need your help to stop it. She has aligned with big hotel interests against the interests of regular Bostonians.

posed any danger.

Boston police and EMS didn't immediately respond to requests for comment on Wednesday.

Hope Coleman said Wednesday that she never could have imagined that calling for medical help would have ended in her son's death.

"I was just trying to help my son," she said through sobs at her lawyers' office. "I brought him into the world. The police shouldn't have took him out."

The lawsuit says Hope Coleman became concerned about her 31-year-old son because he refused to come inside from the apartment building's front stoop.

She said she told the 911 operator she didn't want police because she worried that would agitate her son, but the operator said it was the policy for officers to accompany EMTs.

The lawsuit says Terrence Coleman, who had gone inside the apartment by the time EMTs arrived, became upset when he saw blue flashing lights and told them he didn't want to go to the hospital, but the EMTs insisted he come with them and tried to grab him. It says the officers burst through the door when they heard a scuffle, tackled the man and shot him.

Suffolk District Attorney Daniel Conley said in August that Officer Garrett Boyle's use of deadly force was justified because the lives

of officers and emergency medical technicians were in danger. Conley said Terrence Coleman had pulled a 5-inch knife from a bag and attacked the EMTs who were trying to help him and then began slashing at the officers who came to their assistance.

The lawsuit says a knife was recovered from inside the apartment while the officers and EMTs said Terrence Coleman had attacked them in the foyer outside the apartment.

The complaint says the city has flawed 911 protocols for responding to mentally ill people who need assistance. It also says the city does not adequately train officers on how to deal with people with mental illnesses and that the training programs that do exist "erroneously suggest that all persons who suffer from mental health disabilities are violent and dangerous."

Sophia Hall, an attorney for the mother, said they hope the lawsuit will propel policy changes in Boston and perhaps across the country.

"What we're seeking is not only justice for Hope and Terrence, but for some kind of system change," said Hall, with the Lawyers' Committee for Civil Rights and Economic Justice, which filed the lawsuit along with attorneys with Fick & Marx LLP.

Hope Coleman says her son's death has turned her life upside down. A cake she made for his birthday last month still sits uncut in her kitchen because she can't get herself to do it without him.

"I'm never going to be normal," she said.

sturdy antique. Now premier Lyric Stage Company of Boston guest director Scott Edmiston (the company's visceral 2017 revival of "Who's Afraid of Virginia Woolf?") has adapted the public domain work with the care of a master restorer.

The result is at once a moving pre-feminist statement and theater as inviting and lasting as a Chippendale armchair.

Would O'Neill approve of the tightened result? Actually, the dramatist himself substantially revised the play—initially entitled "Chris Christopherson" in 1919—before it opened on Broadway as "Anna Christie" in 1921 (with a 1993 Tony Award-winning revival starring the late Natasha Richardson).

O'Neill turned originally innocent but vulnerable New York City native Anna into a weary prostitute returning home after many years to see her father Chris. Coal barge cap-

tain Christopherson, who once had served as a bosom on many ships throughout the world, had sent her to the farm of Minnesota relatives after the death of her mother.

In the early back story, Anna reveals that she had worked like a dog there, had been raped by a cousin and had suffered at the hands of various uncaring johns.

Anna's transformation from a bitter, manipulated woman to one determined to define her own life and take it in a much more positive direction remains the essential arc of this still-timely play. Edmiston has honed this scenario in his adaptation in good part by trimming a cast of about a dozen characters to five.

The removal of saloon owner Johnny the Priest, longshoreman, storm rescuers and rescued shipmates—except of course the pivotal boyfriend—not only does not diminish dramatic scenes but also makes them more intimate. In fact, Karen Perlow's nuanced lighting and Dewey Dellay's evocative sound design give both the South Street Seaport saloon and

the Simeon Winthrop, Christopherson's coal barge you-are-there immediacy and vividness.

Lanterns sway on the ship to help convey the force of the storm from which Mat is rescued. Designer Janie E. Howland's creatively configured wood boards make the move from the saloon to the barge not only smoothly accomplished but entirely convincing.

Most of all, under Edmiston's sensitive guidance, the first-rate cast guarantees clear sailing for this all-too-rare revival. Lindsey McWhorter captures Anna's early combination of resentment and reserve and richly develops her growing resolve to make a life change. Fans of Greta Garbo's arresting work in the 1930 pre-code film will find this very talented actress—an IRNE Award winner for her fine portrayal of a seamstress in Lyric Stage's recent staging of "Intimate Apparel"—equally alluring.

Johnny Lee Davenport has the right crustiness and inner emotional conflict as her previously distant father. O'Neill may have been influenced by Irish playwright John Millington

Synge's poetry about fate (for example, in his "Riders to the Sea")—a theme that Davenport delivers with gusto in his concern for what he calls the "devil sea."

Dan Whelton—who caught the complexity of upstart Nick in the Lyric Stage "Who's Afraid of Virginia Woolf?"—persuasively moves from a transparently shallow Mat to a newly sensitized hunk that truly cares for Anna. Nancy E. Carroll finds Marthy Owen's attitude with boyfriend Chris and generosity of spirit counseling Anna about men. Cited James R. Milord ("103 Within the Veil") brings heartiness and good camaraderie to bartender Larry's easy banter with Chris. Designer Charles Schoonmaker reflects Anna and Mat's respective character developments in their period attire.

If Chris terms the fog a "dirty trick," Anna sees it as a kind of metaphor for her redemption. By contrast, there should be no disagreement about Lyric Stage's "Anna Christie." Book passage without delay.

The e-mail continues the companies set up an online tool for sending pre-written complaints to city councilors and Mayor Walsh.

The company claims the proof that Wu is in bed with Big Hotel is that her proposal (which City Councilor Lydia Edwards is also working on) would limit complete rental of units on AirBNB to 30 days a year, would bar renters from subletting their units to out-of-towners and would probably be worse for your privacy than even a poll on Facebook by requiring owners of Airbnb units to notify their neighbors and supply information to the city—although much of the information, including rental prices, would have to be supplied by Airbnb to the city, not by the unit owners.

Airbnb does not point to a large influx of campaign cash from Big Hotel to Wu, probably because state campaign-finance records show no such thing in 2018. It also doesn't note that Wu has proposed banning investor-owned units from the rental-share market completely, possibly because that would not fit in with Airbnb's alleged theory that Wu is going after the little guy.

Wu and Edwards, and before them, Sal LaMattina, argued that an unfettered room-share market in Boston is making it more and more difficult for actual Bostonians to stay in the city, as investors buy up entire buildings to rent out on Airbnb and similar platforms.

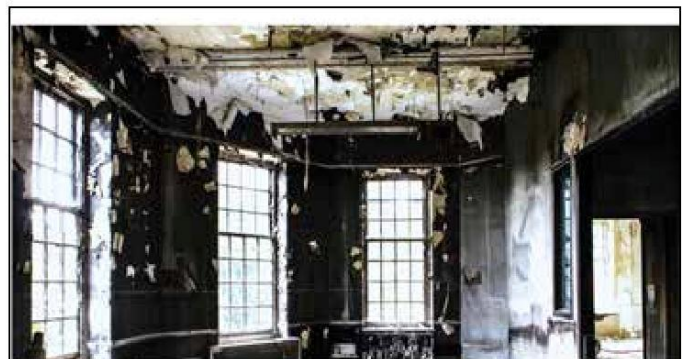

Association (B/FSNA) at a social on Tuesday, April 17 at Southern Proper, 600 Harrison Avenue. WSANA president George Stergios estimated attendance at about 50 people.

Guests snacked on hush puppies, deviled eggs, pork rinds and other savory treats as they got acquainted and shared their interests and concerns. B/FSNA co-president Vadim Kuksin commented on the interaction between the two groups. "I think they are mingling well. This is the third time we've done a combination, so there are some familiar faces, which is nice," he observed.

Leaders from both groups talked about their organizations' efforts to give back to the community. Andrew Parthum, founder and co-chair of B/FSNA's college book and supply scholarship program, gave an update on the application process. Parthum explained, "We're looking for applications. The application is on the web site and we encourage South

End high school seniors to apply."

Parthum added that the only requirement to apply is South End residency and the deadline is May 19. He encouraged interested students to download the application at [www.blackstonefranklin.org](http://www.blackstonefranklin.org). Stergios reported that WSANA donated \$1,500 to the South End Branch Library from the proceeds of the raffle at the annual Worcester Square Christmas Tree Lighting.

"We've never done anything for the library, and they have plans to make it much better, much more accessible to more people, so we figured we'd give it to the library this year. It'll buy them some books!" Stergios said.

The heads of both groups reflected on the success of the social. Stergios observed, "I thought it went very well. We had more people than I expected, and I thought people mixed very well. I think we are going to try to do this once a year."

In terms of mingling among the two groups, Kuksin said, "We'd like to do more of this type of thing. We did a joint social with

the Rutland Street neighborhood association, which was nice. These people are our neighbors just as much as the members of our group."

On future collaborations with WSANA, Kuksin said there was "nothing planned, but George and I agreed that we should do more things together." Looking ahead, Kuksin and Stergios previewed upcoming activities in their groups. Stergios said that future agenda items for WSANA include a presentation at WSANA's April meeting by Geoffrey Reilinger, founder and CEO of Compassionate Organics, which seeks to open a medical marijuana dispensary and eventually, recreational marijuana retail on Tremont Street in the South End, and a visit and update from state senator Sonia Chang-Diaz at WSANA's May meeting. Kuksin said that B/FSNA is planning a reprise of the popular Summer Soulstice festival in Blackstone Square in June. "We are figuring out funding with Washington Gateway Main Street."

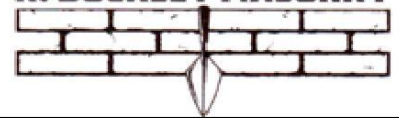
