## All together?

South End's myriad of neighborhood associations talk mergers Residents of both the South End and other downtown areas have long been perplexed that the South End has 16 individual neighborhood associations, some covering as few as three or four square blocks, while other neighborhoods have one or two associations to represent them.

The idea of consolidating as a means of pooling resources and increasing clout with the city has arisen periodically, and over 20 years ago, the South End Forum came together to discuss and tackle concerns that are common across the South End, such as public works and traffic.

Consolidation talk became more concrete recently when the New York Streets Neighborhood Association, which formed to serve residents of the Ink Block complex, began the process of joining the Old Dover

Neighborhood Association (ODNA), which had previously included that area. ODNA president Ken Smith said, "It isn't a complete merger yet, but the intention as we re-affiliate is to one day be one association again. We never stopped supporting and representing our Old Dover members who lived in the north side of East Berkeley and will continue to during this period of transition."

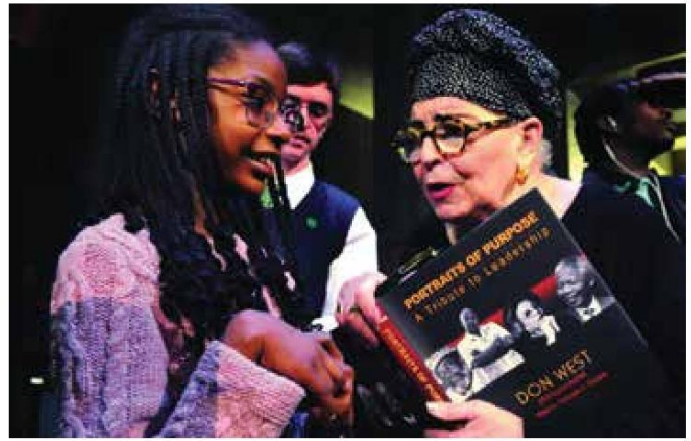
## February

## March

### From Springfield to Boston to Washington: Youth Lead Movement to End Gun Violence

On Thursday March 14th, young leaders from around Massachusetts stood in front

of the Smith and Wesson headquarters in Springfield, where the assault weapons used in the Parkland, Aurora and San Bernardino shootings were produced.

Teens traveled by bus from Boston, carpools from Holyoke, and by foot from Springfield, walking the quarter of a mile from Springfield Central High School. They led over 200 youth educators, faith leaders, and allies in asking Smith and Wesson's CEO, P. James Debney, to meet with students and become an industry leader in addressing

gun violence in this country.

Boston student leader Ekran Sharif said, "This gun [Smith and Wesson M&P-15] was never intended to be used by civilians. We are here at Smith and Wesson to demand that executives from Smith and Wesson engage directly with us, specifically with youth leaders, about how their company will be part of the solutions to end gun violence."

## Obituary: Carl Lizio

For the past 45 years, Carl Lizio was a familiar face in the South End. Following the motto "Doing Well while Doing Good", Carl was known as a friendly local, greeting friends and neighbors with respect, cordiality, and usually a good joke.

A native of Dorchester, Carl came to the South End in the 1970s when the wrecking ball of urban renewal was still swinging mightily. Along with his brother, Stephen, Carl bought his first building in 1972 and eventually went

on to renovate nearly 60 South End buildings, most of which were long vacant and in danger of being destroyed.

made the list as being at the pinnacle of their careers and as individuals who have made, and are making, positive contributions to the Greater Boston community while serving as role models for the next generation of leaders.

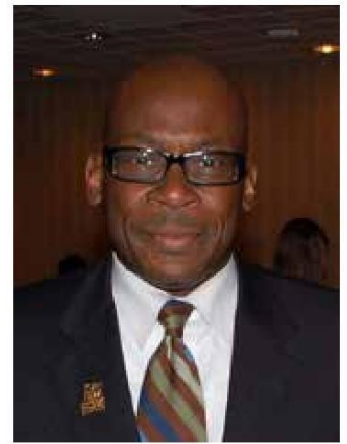
## USES Honored with GK10 Award

the coming weeks. For over 132 years, Ellis has been an iconic early education leader in Boston's South End and has strengthened Boston's inner city working families with high quality education and care for children, youth and vulnerable adults.

"Leo has been an incredible leader who has accomplished more than we could have imagined," Said Larry Hughes, Ellis Board Chair. "The retirement of such a strong leader is always challenging for a lean organization such as Ellis. Thankfully Leo has built a great team and has an engaged board to help us through the transition. While Leo will never be replaced, we are excited about a new generation of leadership to continue our mission of serving the working families of Boston's South End and Lower Roxbury."

In 1986, Leo Delaney joined Ellis as Chief Executive Officer just one year after Ellis celebrated its 100th anniversary. The organization was enduring financial difficulties and Delaney was given two years to assess the situation and develop a plan for Ellis' future. Delaney quickly turned Ellis into an anchor in the South End with continued services to the community and expanded its reach.

Killed in hit-and-run crash**

For decades, in the South End and all over Boston, Ted Schwalb was renowned for his extravagant wit and warmth, his outsized personality and appetite for conversation, friendship, art and life. He was a compassionate bon vivant, and an enthusiast with a critical eye. A graduate of Marblehead High

School, and Mass. College of Art, and an accomplished painter, he taught art at Stoneham High School for decades.

He held hundreds of memorable dinners in his art-filled home, and when he traveled to Chicago to celebrate his 60th birthday, his friends lamented to the Boston Globe that the beloved South End personality would not be dining with them. After his retirement, he spent winters in Mexico, returning every Spring to Boston. He is warmly remembered by his sister, the Cambridge artist Brenda Star, his nephews and their families, and countless others. Donations in his memory can be made to the Mass. College of Art.
