## EXHIBITOR & VENDOR SPACE AND MENU REGULATIONS

1. By Submitting this Application, you signify that you agree to comply with all terms of this agreement.
2. Payment is due upon receipt of completed application form.
3. Space will not be guaranteed if terms or conditions are not met. Returned checks and charge backs will be subject to all legal remedies including collection fees and/or possible criminal prosecution.
4. Contracts may not be cancelled and there are no refunds after 9/1/19. Refunds may be issued via check prior to that date for the full amount paid minus a \$30 Cancellation fee.
5. The event will be held rain or shine, October 5th, 2019, from 1:00 to 7:00, in Cooper Riverside Park Park.
6. No displays over 10' in height or extending beyond the 10' X 10' booth area are permitted without explicit written permission from MOBPRIDE. Vendors are responsible for their own tables, chairs, display, etc.
7. All business or other activity for which vendor has rented space must be conducted WITHIN THE DESIGNATED BOOTH AREA ONLY. Distribution, layout, or hanging of any items outside the designated booth area is not permitted.
8. All locations will be assigned. Failure to adhere to assignments could result in forfeiture of participation in future events and vendor may be requested to leave with NO REFUND.
9. Loud Music, amplified voices, squawk boxes, or any other type of sound amplification is NOT PERMITTED. No generators will be permitted without written permission from MOBPRIDE.
10. All material deemed offensive by MOBPRIDE will not be permitted to be sold or displayed. Any vendor refusing to remove such material may be required to leave with no refund.
11. PRIDEfest times are 1:00 to 7:00 pm. All vendors are required to be completely set up by the 12:30 pm AND REMAIN OPEN UNTIL THE CLOSING OF THE FESTIVAL AT 7:00 PM. Early closure may result in forfeiture of participation in future events. A \$25 clean up fee will be charged to any vendor who leaves trash behind. PRIDEfest set up time will be from 11 am until 12:29 pm. No vehicles will be allowed in the park during PRIDEfest. All vehicles must be removed from the festival area prior to the start of the festival. Vehicles will be allowed back in the festival area once deemed safe by the Police and MOBPRIDE after the close of the festival.
12. Food Vendor menus require approval so that duplications are avoided. This will be done on a first come basis.
13. No vendor may sell any alcoholic items without express written permission of MOBPRIDE. Sale of these beverages could result in expulsion from the festival and the forfeiture of participation in future events.
14. It is the Vendor's responsibility to pay the appropriate TAXES AND FEES to the State of Alabama. MOBPRIDE assumes no responsibility whatsoever for collecting or remitting taxes and/or fees of any kind that may be due from vendor.
15. All Vendors & their representatives are expected to monitor themselves on all matters of conduct, attire, etc. Any vendor or employee not acting in good faith or not showing dignity and respect to businesses and individuals may be asked to leave without refund.

### WAIVER OF RESPONSIBILITY

For good and valuable consideration, including permission for the signer to participate in MOBPRIDE's PRIDEfest and related activities to be held October 5, 2019, I, the signer for myself and my group, including all successors, assigns, guardians, heirs, administrators & personal representatives:

1. Agree that prior to participating in PRIDEfest, I will inspect the facilities and equipment to be used, and if I believe any of them to be unsafe, I will immediately advise the appropriate event supervisor.
2. Acknowledge that I fully understand that I will be engaging in activities that involve risk of serious injury or death, including economic losses, which might result not only from my own actions, inactions or negligence, but also of others, condition of the facilities or equipment, rules of play, or use of this type of equipment or activity.
3. Assume any and all risks of personal injuries to my group and myself, including but not limited to medical bills, hospital bills, permanent disability, partial disability, and death and damages to my property, real or personal, caused by or arising from my participation in the event or activity.
