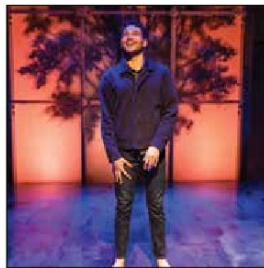

that “We all desperately need an opportunity to laugh in the midst of this messy world we live in.” Veloudos’ sublime effort will have fans of the film and the musical as well as newcomers to one or both savoring the laughter as well as the liveliness of this crack revival.

The musical’s “messy world”—as aficionados know—is a class-conflicted 1909 Edwardian England as chronicled in the memoir of Montague “Monty” Navarro. In the pivotal back story, Navarro’s mother was disinherited by her uppity D’Ysquith family for marrying an outsider. Learning that eight men and women stand between him and earldom, Monty proceeds to make his way to the title of Lord by way of a variety of

murders. While union with his love Sibella also seems to elude him, a different romance develops with Phoebe D’Ysquith, a relative of one of the victims.

Will Monty be caught? What will happen with Sibella and/or Phoebe? Even those familiar with the answers will enjoy the humor, tangled romancing and plot twists. Essential factors are the musical talents of the actor playing Monty and the versatility and comical gifts of the actor playing eight roles. The great news here is that Jared Troilo makes a dashing and charming murderer and Casey a hilarious chameleon as the very different D’Ysquith victims.

Troilo, a sensation in the Lyric Stage Company’s recent solid revival of “The Last Five Years,” once again displays his robust and richly lyrical voice—this time with the

clever intricacies and light-heartedness of the Robert L. Freedman–Steven Lutvak score. Casey, marvelously manic in the company’s entertaining edition of “One Man, Two Guvnors,” is clearly relishing the chance to swiftly become each of the D’Ysquiths—notably a raccoon coat-sporting show-off and a racist world traveler Lady Hyacinth. Casey is as appealing in his own way as Jefferson Mays was in the Broadway original. Troilo and Casey bring terrific timing to the suggestive duo “Better With a Man.”

Elsewhere, Aimee Doherty as Sibella and Jennifer Ellis as Phoebe turn in a sharp contrast as the women in Monty’s life. Doherty captures Sibella’s coquettishness and elusiveness as she pursues financial comfort. She also finds her on-going caring in the smart solo “Monty.” Ellis catches Phoebe’s remarkable

sincerity and her opera-caliber voice shines especially in duet with Troilo on “Inside Out.” Veloudos brings fine pacing to the tricky and winning trio “I’ve Decided to Marry You.”

Karen Murphy makes the most of enigmatic Miss Shingle, and Leigh Barrett is scene-stealing good at the impactful late second act dinner. In a strong production design, special kudos go to Johnathan Carr’s inspired projection—especially as Monty and the Parson appear to climb to the top of the church. Gifted music director Matthew Stern and a talented orchestra easily fulfill the score’s demands.

Veloudos and a cast to treasure make “A Gentleman’s Guide to Love and Murder” resonate with timely subtext about hate even as they make us laugh. The Lyric Stage laugh fest is a revival for all seasons.

the impact of a major closeted author's work on his emotional and sexual life.

That writer is E.M. Forster and the seminal novel is "Howard's End" (1910). Lopez has brilliantly adapted its plotting and themes in a wide-ranging exploration of the lives, loves and legacies of Glass and other 21st century gay men. *Speak Easy Stage* — the first company to present the two-part drama since it won the 2020 best play Tony Award — is giving this long but totally absorbing work (over six hours with several intermissions) an electrifying performance that all theatergoers should find compelling.

Tautly staged by company artistic director Paul Daigneault, "The Inheritance" presents the personal and communal relationships of Glass, his play-writing love Toby Darling and a rich ensemble of diverse characters on a thrust stage for a you-are-there experience for the surrounding three audience sections.

Forster's London is now Lopez's New York City, and the novel's title rural location is now the play's upstate New York home. In Lopez's inspired conception, Morgan — Forster's middle name — serves as a mentor-narrator who reflects on the pre-same sex marriage years when he concealed his sexuality from the public and held off publishing his 1913 novel "Maurice," a frank examination of the title character's orientation.

At the same time, the playwright provides context and contrast for the drama's connections to "Howard's End." Theatergoers learn that Eric's veteran grandfather helped

liberate Dachau and that he inherited his West End Avenue rent-controlled apartment from his grandmother Miriam, a refugee from Germany. Once Toby moves in with Eric, the novel's Schlegel sisters become the parallel for the pair.

Eventually, the play's rich title takes on specific relevance. Walter Poole — a friend for whom Eric cares greatly — leaves him the upstate home in a note. Walter's once-closeted real estate broker love Henry Wilcox and his sons attempt to conceal this inheritance (as Henry Wilcox and his son Charles do the willing of Howard's End to Margaret Schlegel in Forster's novel). Elsewhere, switched bags in the play call to mind the switched umbrellas in the novel, and both works include an unexpected embarrassing recognition. At various points in the play, class factors — imminent eviction for Eric from the rent control flat and well-to-do Trump-supporting Henry's business dealings with Saudi Arabia — come into play.

Throughout both parts of the play, characters' honesty and ethics are tested and examined as much as their love and caring. Toby in particular denies his real childhood in writing a hit play. Later he turns a new relationship with a vulnerable young man named Leo — who resembles Adam, an actor about whom he obsesses — into a situation recalling "Vertigo."

Later Henry will admit that Walter bequeathed the cherry tree-adorned upstate New York home to Eric (a pivotal admission that parallels the one in "Howard's End." In one emotionally charged stretch of the play, Eric, his friends and Henry share a wide-ranging and insightful discussion about what it means to be a gay man, the toll of

AIDS, assassinated Jewish activist Harvey Milk, the absence of a film about black gay writer-leader Bayard Rustin, homophobia and how far America has progressed with regards to diversity.

Ultimately, as the full importance of Walter's home is revealed, Eric continues to serve as both a role model of caring — especially as he protects budding writer Leo — and someone as special as the cherry tree he cherishes there.

The superb *Speak Easy Stage* cast fulfills all of the Herculean challenges of Lopez's epic play. Eddie Shields is alternately touching and stirring as Eric — whether embracing his heritage, struggling to find real mutual love and trust or learning to fully value his own worth as a man. Mark H. Dold has all of Morgan's reticence as he follows and advises the 21st century gay men who have no trouble accepting their identity. He also catches Walter's impassioned caring for Eddie. Gifted Shields and Dold give richly complex performances for the ages.

Jared Reinfeldt captures Darling's cruelty in putting down initially self-effacing Glass and his growing delusion regarding Adam, Leo and fame. Dennis Trainor, Jr. finds Henry's no-nonsense business priority and his affecting memories of his love with Walter. Special credit goes to Yo-El Cassell for nuanced movement and intimacy direction and Karen Perlow for evocative lighting.

"The Inheritance" should have theatergoers of all colors, creeds and orientations giving serious thought to their own views about themselves and others. In an age of growing polarization, Lopez's poignant play and *Speak Easy Stage*'s soaring staging make its timeliness a powerful legacy for everyone.

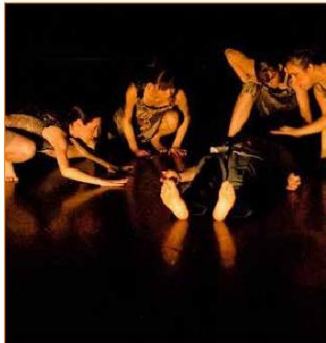

BCA's Boston Dancemakers Residency seeking applications



Boston Center for the Arts' Boston Dancemakers Residency is now seeking applications from choreographers, dancers, and other movement artists from the greater Boston area. This robust residency is designed to support new work from conception to performance and assist artists in taking their artistry to the next level.

Produced through a partnership between Boston Center for the Arts (BCA) and Boston Dance Alliance (BDA), this intensive residency is unique in scope and vision, with the intent to be transformational rather than transactional.

Choreographers participating in this comprehensive and competitive program receive support for research, development, rehearsal, production support, marketing, and mentorship. The residency provides a regional three-day retreat, eight weeks of intensive studio time, access to discounted rehearsal space, a choreographer stipend, rehearsal pay for up to six dancers, and a showcase of the work created.

Two residents will be selected for the 2022-2023 season for eight weeks or an equivalent of fifty-six days of rehearsal and performance time. Infant formula information

COMPILED FROM THE USDA AND AAP

Some steps you can take to ensure the safety of your infant's formula include:

- Learn more about choosing an infant formula that's safe for your baby.
- Do not feed your baby cow's milk or other non-dairy milks until 1 year old, unless you've talked to your child's pediatrician.
- Don't make homemade infant formula or water-down formula; there are serious health and safety concerns.
- Do not buy formula online that comes from outside the U.S., which could be counterfeit, have a fake label or a wrong use-by date.
- Prepare and store infant formula according to the manufacturer's instructions; do not water down formula.

- Properly clean, sanitize and store infant feeding items.
- Always wash your hands when handling formula and feeding items.
- Talk to your pediatrician about introducing complementary foods by 6 months (no earlier than 4 months).

- Be aware of your surroundings, especially at night. Keep your head up. Make quick eye contact with those around you and when possible, try to avoid poorly lit or isolated areas.
 - When possible, walk with friends and people you know especially late at night.

be “worthy of its prominent location in the South End Landmarks Protection Area.” Part of this will include reusing the brick facades of three of the buildings on Wareham Street.

The project would be just across Albany Street from the under-construction Exchange South End complex, which will include life-sciences lab space next to Boston University’s National Emerging Infectious Diseases Laboratory, which in turn is next to BU Medical School’s campus and research facilities, which leads into the campus of Boston Medical Center.
