## Historic partnership: Disney and BGMC

**Disney PRIDE in Concert,** performed by Boston Gay Men's Chorus, at Boston Symphony Hall, June 25-26. 617-542-SING or [bgmc.org](http://bgmc.org)

Last year Boston Gay Men's Chorus music director Reuben M. Reynolds III announced that BGMC and LGBTQ experiences, observed, would present "Disney PRIDE in Concert" June 25-26, 2022 at Symphony Hall. The concert is slated to be "a musical celebration of LGBTQ life, love, family and perseverance." It will also reimagine Disney's song

catalog. Reynolds III, speaking of the affinity between Disney characters and LGBTQ experiences, observed, "Characters are often struggling to fit in and to accept themselves." The Disney Concerts-BGMC collaboration represents the first time Disney

## Two delights for the summer

Are 65 minutes enough time to make a play sing on stage? Gifted multi-talent Jacqui Parker (IRNE and Norton Awards), in her playbill director's note for the Lyric Stage Company of Boston area premiere of "The Light," calls the Loy A. Webb work "my theater song." While the engaging play seems to tackle too many issues, its evolving romance does take on a striking jazziness—particularly thanks to strong performances by Dominic Carter and Yewande Odetoynbo as the lovers in question.

Maya Angelou, Beyonce, Michelle Obama and Ruth Bader Ginsberg on the backdrop dining room wall of a handsome Hyde Park, Chicago condo (kudos to scenic designer Baron E. Pugh) promise serious attention to women. The condo owner is Genesis, the savvy principal of a black charter school. Her fireman boyfriend Rashad grooves as he enters before her.

If their conversation and body language display true feeling and love, their future together is uncertain. Although Rashad proposes marriage, a dispute about the integrity of a performer—for whose concert he has V.I.P. tickets—erupts into a verbal debate about the relative worth of Black women and Black men and threatens the future of their relationship. Towards the end of the play, there are significant revelations—especially regarding the performer. Rashad assures Genesis that he is there if she needs him. Audience members will have to decide on their own if the ending is convincing.

Reservations about the overly busy play aside, Parker's sharp direction and the fine performances of Carter and Odetoynbo make the play worth seeing. Carter captures Rashad's embrace of life, deep love for Genesis and insecurities about his career. Odetoynbo finds all of Genesis' passionate feelings for Rashad as well as her ongoing uncertainty about the durability of their love in the face of personal differences.

Rashad and Genesis, richly characterized and likable, may ultimately have more to offer than Webb's earnest play. The true radiance in "The Light" proves to be the chemistry between director Parker and actors Carter and Odetoynbo.

"Wicked" lost out for the 2003 best musical Tony Award to "Avenue Q" for good reason. While glossy and "popular," it needed more of the latter's heart and a stronger score (as was the case with composer Stephen Schwartz's "Pippin"). Even so, Idina Menzel was electrifying as Elphaba and Kristen Chenoweth radiant as Glinda—so much so that they established a stage twosome that has helped the visually stunning show—rightly honored with scenic and costume design Tony's (respectively for Eugene Lee and Susan Hilferty)—run for many years.

The good news about the tour at the Citizen Bank Opera House is a strong performance that will please the musical's legions of fans.

Under the taut direction of veteran Broadway director Joe Mantello ("Assassins," "Take Me Out"), the leads and supporting cast bring vocal magic to strong and middling numbers alike. Lissa deGuzman has the right perseverance and strong will as Elphaba and properly builds the power of "Defying Gravity," the show's best song. Jennafer Newberry, who displays operatic tone, and deGuzman make the most of the friendship anthem "For Good." Jordan Litz has all of Fiyero's independent demeanor and his growing love for Elphaba. Lisa Howard captures Madame Morrible's singular meanness.

To borrow from the score, "Wicked" is clearly dancing through life. Musical buffs know that like Glinda it has more style than substance (not to mention sizable changes from Gregory Maguire's novel in Winnie Holzman's book). Still, there is a lot of enjoyable life in this tour.

On June 12, 1982 5 Star Travel Services opened its doors on the top floor of 176 Newbury Street in the Back Bay of Boston. The first owner of the Agency was Anne Romano, who opened the agency with her friend Shari Didinsky. Ms. Romano was the mother of the then Manager of the Boston Ramrod bar on Boylston Street. This indicates that there has been a connection between the Agency and the Gay community since day one.

In 1986 Anne sold the Agency to Erika and Neil Daykin who moved the Agency to the Penthouse at 164 Newbury Street. They remained the owners of the Agency until 1991 when Paul Moreno and Stephen Barlow took over the helm, and have been the owners since. To this date the Daykins are still involved with 5 Star Travel.

Moreno and Barlow focused their clientele to cater mostly towards the Gay Community. They joined the International Gay and Lesbian Travel Association (IGLTA) where Moreno was elected twice as a Board Member. The Agency received several Travel and small business awards in the 90's and early 2000's. Their business grew from a mere \$700,000 in annual sales, to over \$3.5 million a year, and were at one point the top selling Agency for the popular gay chartered cruises in the East Coast. Then came the internet and travel-sites.

In 2004 5 Star moved to Columbus Avenue in the South End as more space was needed for their office space. *"This was the best move we ever made"* Moreno said *"We were on a corner location and had several more walk-ins."*

In 2018 5 Star Travel joined the Tzell New England Travel Group, a conglomerate of nearly 50 Travel Agencies in New England. With their combined sales of well over \$1 Billion, the Agency Network (and all its affiliated agencies) are able to provide their clients with competitive deals such as the major travel sites, but still provide the small personal 'pop 'n pop' Agency touch.

Last year 5 Star Travel lost its Manager, Jack Campbell, after a battle with cancer, who worked for the Agency for 27 years. He was a beloved associate of the Beantown Softball League, Boston's Gay Softball Teams, arranging most of their group travels to tournaments and World Series.

Moreno and Barlow look forward to many more years as part of the 5 Star Travel family, and would like to remind everyone that *"Without a Travel Agent, you are on your own"*.

Concerts has partnered with an organization to create an LGBTQ-specific concert. The 250-member BGMC and its 25-piece orchestra will perform new arrangements of Disney songs by assistant music director and pianist Chad Weirick.

Asked about his thoughts on the Disney movies, the concert and his preparation for it, Weirick reflected, "I'm a Disney fanboy. My first draft of Disney PRIDE in Concert was about 200 songs and a five-hour production. But I was pretty determined from day one that this was not going to be just about Disney movies. I wanted to encompass the entire company, including TV, movies, and the theme parks. I really wanted songs from every aspect of Disney because I think for most Disney fans, all those things are part of the Disney experience."

As for the arrangements, he explained, "All of the songs in this show have new arrangements for the chorus accompanied by an orchestra. The way I hung the show together is that from day one I pictured the show as a giant theme park and the experience of the audience is as if they were visiting Disney, but experiencing LGBTQ stories."

One of the arrangements about which Weirick feels very deeply is "It's a Small World." It's always annoyed me that people dismiss "It's a Small World" as just a stupid little kid song that gets stuck in your head. The first time I heard that song, I was like, but have you really listened to those words? Do you know the history of the song as an anti-war statement related to the Cuban missile crisis? In the show, the first moments of that song are sung a capella with no orchestra. It's just them. It's a big choral moment, and they slowly sing the first verse of "It's a Small World,"

with meaning and purpose to say, hey, it's a world of laughter, a world of tears, a world of hope and fears. But you know, there's one thing we share, it's a small world after all. It's such a powerful and universal message."

Weirick also stressed the uniqueness of the concert. "This is certainly a landmark in the LGBTQ+ choral world. In the end, the Boston Gay Men's Chorus had the pieces that broke through: the quality of musicianship, powerful storytelling, a track record of accomplishment, and the production capacity to stage this with a 25-piece orchestra at Boston Symphony Hall, one of the greatest in the world. Even though we only have a handful of paid staff and our chorus members are all volunteers, we rehearse and perform at a professional level. In the end, I think Disney understood that their material would be in good hands. They trusted us.
