

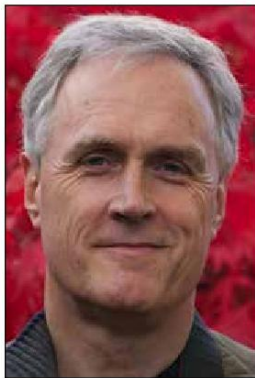

Barry Bock, RN, who has led the program for the past nine years.

“The Board is excited about Dr. Sullivan joining us, and continuing her long history of servant leadership,” said Board of Directors Chair Brett Painchaud. “She has extensive experience ensuring that underserved patients are cared for in a respectful, dignified manner and that background will be invaluable to BHCHP.”

Dr. Sullivan has spent her career securing equitable access to healthcare for marginalized patients, including people who are incarcerated and victims of domestic violence and sexual assault. She joins BHCHP from VitalCore Health Strategies, a leading provider of healthcare for correctional institutions. She is also a former assistant deputy commissioner of clinical services for the Massachusetts Department of Corrections, managing compliance and oversight for an \$850 million contract providing a full range of treatment services.

Dr. Sullivan notes many parallels between correctional and community healthcare. “I am

very experienced with indigent populations not getting adequate treatment for substance use disorder, medical, mental health, and other related needs,” she said. “The CEO position appealed to me because it represents the culmination of my life’s work.”

Among Dr. Sullivan’s career highlights are initiating a medication-assisted treatment program within a prison system that reduced recidivism due to post-release relapse by 40% in its first year and creating and implementing the Federal Bureau of Prisons’ first transplant program.

Since 1985, Boston Health Care for the Homeless Program has been delivering exceptional medical and behavioral health services to homeless individuals and families in Greater Boston. Each year, BHCHP provides care to over 11,000 patients wherever they are: in the streets and back alleys; at over 40 clinics in adult, family, and domestic violence shelters; at our clinics at Massachusetts General Hospital and Boston Medical Center; and in our 124-bed medical respite facilities, the Barbara McInnis House and the Stacy Kirkpatrick House. Recently David Angus—the company’s music director since 2010—discussed the 1867 opera and the BLO-CSC collaboration.

“We do the theatrical side and the musical side,” Angus explained. Noting that “Opera has so many facets,” he offered, “When everything is working together, it’s such a powerful combination.” For the Boston Common English language edition, collaborators Angus and CSC artistic director Steve Maler are employing the Edward Tracey translation of the original Jules Barbier and Michel Carré French libretto. “It’s a fairly modern translation,” Angus submitted. “It’s all about communication.”

That communication unsurprisingly focuses on the title lovers. “Romeo & Juliet” may be rarely staged—even Angus admits “I’ve never done the whole opera,” but Gounod’s passionate love duets are rightly prized. “The love duets and the fights (as in Shakespeare’s play) are fantastic,” he declared. High points in the opera include Mercutio’s Queen Mab ballad, Juliet’s well-known waltz, Romeo’s declaration of love and their moving closing duet.

To keep the love of Romeo and Juliet at center stage, Angus stressed, “We’ve cut down all the ceremonial material (where the original opera included five acts). We want people to concentrate on the lovers.”

To that end, the production is just over two hours in length including an interval. “It’s all about those fantastic love duets,” he alerted. Even so, this collaboration is add-

ing “spoken text, narration and readings. We want to re-instate some of the Shakespearean sonnets.” Moreover, some supporting roles take on additional importance in the Gounod opera. Tybalt, identified here as Lord Capulet’s nephew, wants Juliet to marry Paris. Shakespeare’s Nurse, here called Gertrude, “has become a bigger part.”

At the same time, the BLO orchestra will be in black at the back of the stage in order not to distract from the singing and acting of the costumed cast. “We’re doing it (the opera) in a fairly abstract way. It’s a deliberate compromise.”

“The BLO chorus will be positioned above the orchestra on the three-level stage. Internationally renowned John Conklin is serving as the production’s dramaturg.

Heading the BLO-CSC cast are Ricardo Garcia—in his BLO debut—as Romeo and Boston Conservatory at Berklee graduate Vanessa Becerra as Juliet. Nicholas LaCesse, an emerging artist at the BLO, is playing Mercutio and Omar Najmi—a frequent BLO cast member—Tybalt. Arielle Rogers-Wilkey, who will perform in upcoming BLO productions of “La Bohème” and “Omar” is Gertrude and Philip Lima Friar Laurence. Joshua Conyers is portraying Lord Capulet and Fred C. VanNess Jr. Paris.

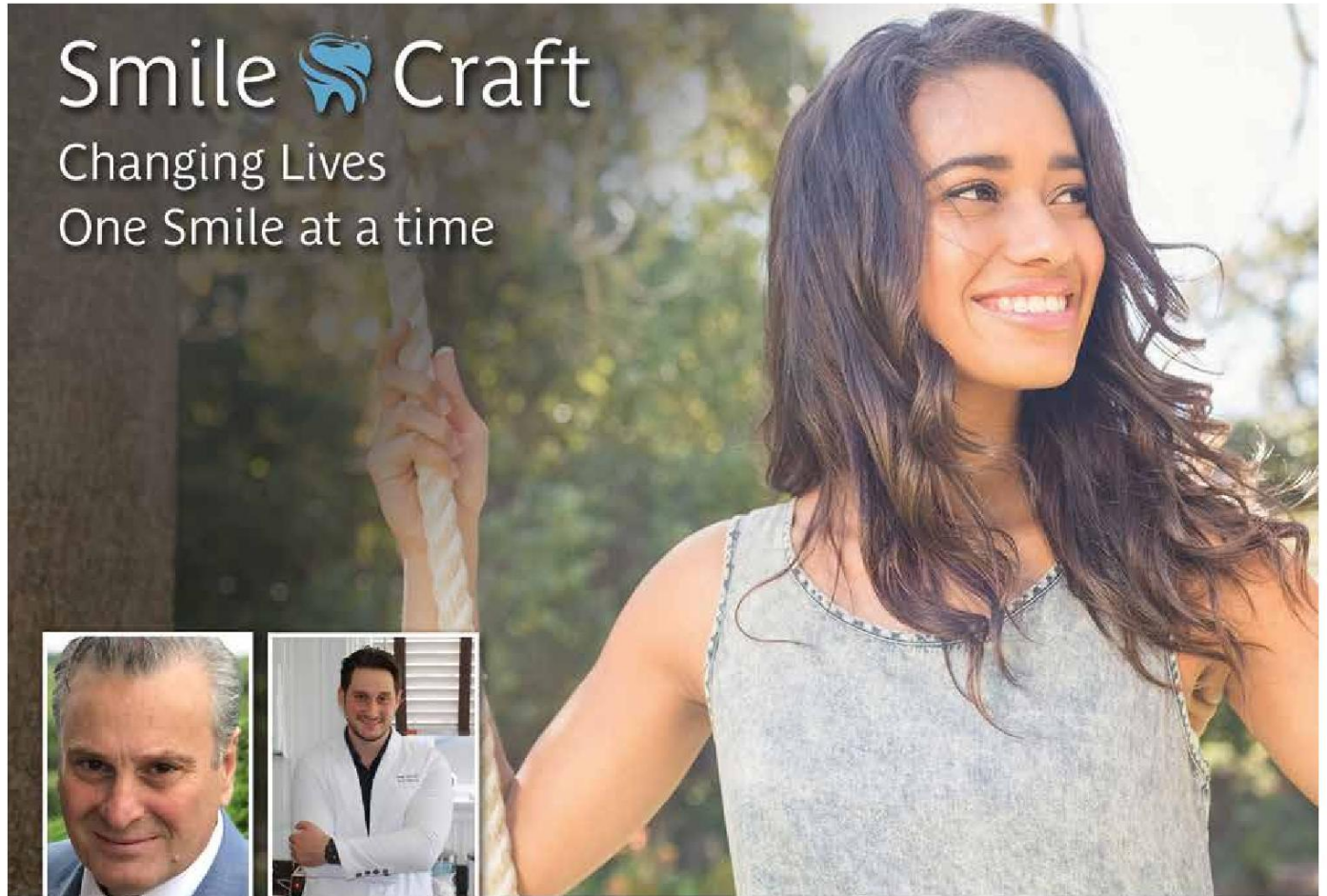
Angus looked to such a joint effort as an ideal approach for the BLO. “We want to be much more of a collaborator and a neighbor,” he signaled. This fall, BLO will collaborate with Detroit Opera on a time-reversed “La Bohème” to be staged at the Emerson Colonial Theatre (September 23-October 2).

LETTER TO THE EDITOR

Alexandra Hotel Development Welcomed

Tuesday July 12th was an exciting day for the neighborhoods of the South End / Lower Roxbury in Boston. The proposed redevelopment of the Alexandra Hotel by Jas Bhogal and Thomas Calus on the corner of Mass Ave & Washington St was approved by Zoning Board Appeals in Boston.

In 1895, the original Alexandra Hotel was named after Alexandra of Denmark and was an apartment building which had a steam powered elevator. It has been vacant since the late 1970's and had a disastrous fire in the 1990's.

As a long time resident of the South End since 1986, I look forward to seeing this historic building being restored and developed soon. This important site will have 70 new condos with 10 onsite affordable units with active ground floor retail. It will be such a positive addition to the neighborhood and have active uses. It is the last linchpin for that important corner.

This building is very important to me. In 1995, I had my photo taken by the Boston Globe in front of the vacant Alexandra Hotel. The front page of the Business Section

announced the support of the late Mayor Thomas M. Menino, the Boston Redevelopment Authority (BRA) with City agencies on improving and redeveloping this historic boulevard through Public / Private Partnerships with the City and the State. The study area was from the MA Turnpike to Melnea Cass Blvd from the South End to Lower Roxbury.

At that time, there were 7 acres of vacant parcels, many boarded up buildings and lack of mixed-use housing & ground floor uses. I was appointed by the late Mayor Thomas Menino to chair the Washington Street Task Force as a volunteer with 28 members. This task force was made of residents, public housing tenants, business owners, and non profits along with elected officials. It was the first time for the South End/ Lower Roxbury area worked together on a joint vision for the future development of this neighborhood. In 1997, recommendations by the Task Force were presented to the City and new zoning was adopted which allowed future development to go forward with neighborhood and City support.

Today, over 2000 housing units have been rehabbed & built. Over 60 % of the units are affordable with 125 new ground floor businesses. These uses are retail, restaurants, fast

casual food establishments, service businesses, and nonprofits. The street was redeveloped by Private/ Public partnerships with the City & the State with developers, nonprofits and property owners. It truly has been a real success.

Many thanks to Kim Crucio from The Mayor's Office of Neighborhood Services, the Boston Planning & Development Agency staff, the South End Landmarks Commission, City Councilors Michael Flaherty, Frank Baker, and Tania Fernandes-Anderson, State Representative Jon Santiago, and shout out to South Enders Bob Minnocci, Steve Fox, Worcester Square Area Neighborhood Association (WSANA) and many others for supporting this project.

I can't wait to celebrate and look forward to the ribbon cutting and groundbreaking for the Alexandra Hotel and see another building be redeveloped. Now let's get this built soon!

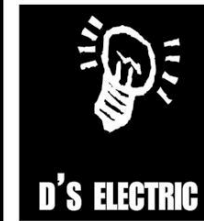
