The City of Boston is designing a safer, greener Harrison Avenue between Herald Street and East Berkeley Street.

The work will continue the public realm improvements started by the redevelopment of parcels along the

corridor. This fall, design plans are being completed and construction is scheduled for next year. Plans include:

#### Better sidewalks and safer crossings

- Rebuild all curb ramps to

- meet accessibility standards
- Widen the sidewalk on the west side between Traveler Street and East Berkeley Street
- Build pedestrian islands at each intersection to shorten

- crossing distances
- Install fresh, high visibility crosswalks
- Use pedestrian-friendly signal phasing at signalized intersections

### Smoother Road

- Repave the road between Herald Street and East Berkeley Street, making a more comfortable experience for all users.

### Separated bike lanes

- Add one-way separated bike lanes on both sides of the street, allowing travel in both directions

### Green and resilient

- Add street trees in new pedestrian islands and on the western sidewalk between Traveler Street and East Berkeley Street
- Build vegetated bioretention islands

at every intersection.

- Use permeable pavers where appropriate

### Public realm

- Install standardized street lighting, replacing non-standard street lights
- Remove the decaying concrete median

### Safer, more efficient signals and traffic

- Where possible, people on foot will get a head start crossing the street before drivers going in the same direction

### Parking

- Keep parking on both sides of Harrison Avenue. Pedestrian safety improvements will require a small amount of parking loss near intersections.

the financial stress associated with buying school supplies for the upcoming year.

This year's BCP Back to School Event made a significant impact, with fun activities, games, free pizza from Sal's along with free ice cream from Ben and Jerry's, and more. Each BCP patient received a new backpack filled with school supplies, a personal hygiene kit, a \$25 Target gift card for back-to-school shopping, a bag of fresh fruits and vegetables, and a bag of non-perishable items to take home. The BCP office and staff distributed 320 backpacks at the event and have already started handing out additional backpacks to families who could not attend and will continue to do so in the following weeks, bringing the total number of children assisted to over 400.

New England Revolution players Brandon Bye, Tomás Chancalay, and Andrew Farrell also made special appearances. Patients and their families had an opportunity to play soccer with the professionals, who talked to children about the importance of staying active day-to-day and focusing on their education.

Jasmine Tinker, a mother of eight who attended the event, has visited the practice since it opened in 2020. "During the COVID-19 pandemic, there was a time when I had no one to help me; I couldn't go to the store because I couldn't take my children, and the office bought groceries for my family and delivered them to our door," she said. "The BCP office has been nothing but a blessing for me. I didn't always feel I had the support system I needed, but now I have that in my children's doctor's office. They are truly like a family to me."

City Councilor John Fitzgerald was also in attendance handing out backpacks to kids as well as Sarah Sharpe, South End/Bay Village Liaison from the Mayor's Office of Neighborhood Services, who helped make sure each family got a bag of produce and a bag of shelf stable food.

Patients and families gathered for an unforgettable event filled with activities and generous contributions from various organizations. The practice expressed deep gratitude to The BASE for their partnership and for allowing the BCP to use their space for the second consecutive year. Children participated in sports and games, thanks to Romel from Canadian Parks, who led an engaging and fun boot camp class. Franklin Sports donated 50 soccer balls, 75 baseballs, and 36 basketballs, enhancing the experience for all. These items were then given to patients to help them stay healthy at home.

The event featured a lively DJ, a photo booth, games, activities, a pitching station, and a soccer station, all designed to create lasting memories. Thanks to the support of our partners—including Plymouth Rock Assurance Foundation, Audax Group, Bain Capital, and Dick's Sporting Goods of Natick—BCP was able to provide amazing backpacks filled with school supplies. Each backpack also included a hygiene kit gift provided by Hope and Comfort.

Families also took home bags of fresh fruits and vegetables and non-perishable goods provided by the YMCA/Greater Boston Food Bank. Finally, BCP would like to acknowledge

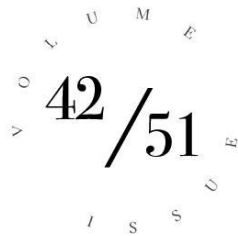

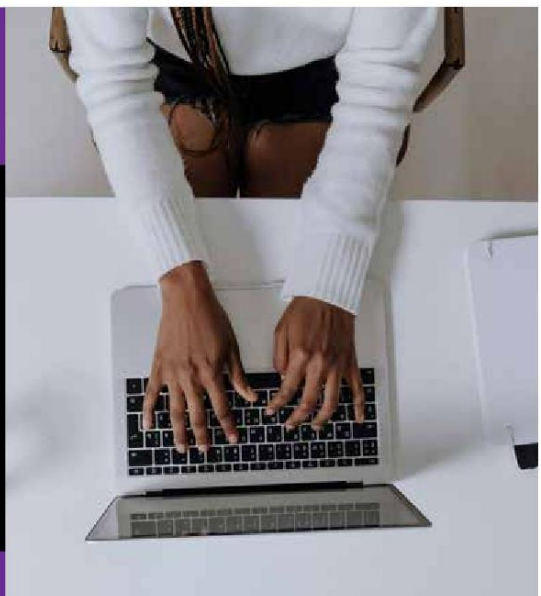
